## INVITATION FOR PREQUALIFICATION FOR MANUFACTURERS/ SOLE AGENTS OF FOREIGN PRINCIPALS OF CONTRACEPTIVES

IRMNCH & Nutrition Program, Punjab intends to prequalify Sole Agents of Foreign Principals of Contraceptives having established credential in terms of Technical, Financial and Managerial Capabilities during the Financial Year 2018-19. IRMNCH & Nutrition Program, Punjab invites applications from Sole Agents of Foreign Principals of Contraceptives for pre-qualification. Pre-qualification is open to all Sole Agents of Foreign Principals of Contraceptives in Pakistan against the list of the essential Contraceptives contained in the Prequalification Documents.

The interested applicants shall deposit non-refundable prequalification fee of PKR 1,000/- (Rupees One Thousand only) in the head of the Account: C02871-Health others in any branch of National Bank of Pakistan and attached the original receipt along with its application for prequalification.

Applications for prequalification should be submitted in sealed envelopes to the office of The Program Director, IRMNCH & Nutrition Program, Punjab 05-Montgomery Road Lahore on or before 05-10-2018 (Friday) till 1000hrs positively and be clearly marked "Prequalification of Sole Agents of Foreign Principals for Contraceptives". The applications received till the stipulated date and time shall be opened publically on the same day at 1030hrs in the presence of the applicants or their authorized representatives who choose to attend.

Technical and Financial Proposals will be called from the Prequalification Firms later on. Provision of false, fabricated or materially incorrect information if found at any stage will lead to disqualification of the applicant under Rule 19 of Punjab Procurement Rules 2014.

All applications should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence as indicated in Prequalification Documents and signature of authorized person. Moreover, signing and stamping of each page of Prequalification documents/form is mandatory.

In case of date of opening is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of applications accordingly. The time and venue shall remain the same.

**Note:** The process shall be governed by the Punjab Procurement Rules 2014.
