Applications for prequalification should be submitted in sealed envelopes to the office of The Program Director, IRMNCH & Nutrition Program, Punjab 05-Montgomery Road Lahore on or before **07-11-2018 (Wednesday)** till **1030hrs** positively and be clearly marked "Prequalification of Pharmaceutical Manufacturing Units and Sole Agents of Foreign Principals of Drugs/Medicines etc." The applications received till the stipulated date and time shall be opened publicly on the same day at **1100hrs** in the presence of the applicants or their authorized representatives who choose to attend.

Technical and Financial Proposals will be called from the Prequalification Firms later on. Provision of false, fabricated or materially incorrect information if found at any stage will lead to disqualification of the applicant under Rule 19 of Punjab Procurement Rules 2014. In case of date of opening is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of applications accordingly. The time and venue shall remain the same.

Note: The process shall be governed by the Punjab Procurement Rules 2014.
